Responsible Agency

The Guyana Geology and Mines Commission was established in 1979 as successor to the Geological Surveys and Mines Department of the Ministry of Energy and Mines, which had succeeded the original Geological Survey of British Guiana. Four technical Divisions carry out GGMC's core functions. These are: Geological Services, Mines, Environment and Petroleum Divisions. The technical Divisions are supported by the Human Resources and Administrative, Finance, Audit and Special Projects Divisions and Land Management Department in carrying out their respective mandates, with legal support provided by the Legal Services Division.

Functions of the GGMC:

- Promotion of exploration, mining, mineral development and the production, supply and sale of minerals and mineral products;
- · Provision of technical assistance and advice in mining, mineral processing, mineral utilization and marketing of mineral resources;
- Conducting mineral exploration using techniques that include geology, geochemistry, geophysics and other remote sensing methods. Conducting research in
 exploration, mining, and utilization of minerals and mineral products. Conducting surface and underground mining to exploit mineral resources;

 Enforcement of the conditions of Mining Licences, Permits and Concessions, Prospecting Licences, Permission for (reconnaissance) Geological and Geophysical Surveys, Prospecting Permits (for Medium and Small Scale operations), Claim Licences, River Location Licences and Quarry Licences, encompassing large, medium and small scale mining:

- · Construction of roads for the transport of minerals and mineral products and assisting in providing access to mining areas
- Collection of rentals, fees, charges, levies etc. payable under the Mining Act and Petroleum Act; and
- · Hallmarking.

PROSPECTING AND MINING AT THE MEDIUM SCALE LEVEL ANSWER TO FREQUENTLY ASKED QUESTIONS

Question: What is a Medium Scale Permit?

Answer: A Medium scale permits cover areas between 150 and 1200 acres and falls into two categories: Prospecting Permit and Mining Permit.

Question: Am I Eligible to Acquire a Medium Scale Permit?

Answer: Section 57(2) of the Mining Act, 1989 outlines the categories of Persons that can be granted a Prospecting Permit (Medium Scale). Medium Scale Permits are specific to Guyanese citizens and institutions where all beneficial owners are Guyanese.

Question: What are the requirements for application for a Prospecting Permit?

Answer: Completed Form 5A Application; Map and cartographic description Medium Scale (PPMS) of area; Payment of a deposit equivalent to half of the first year's rental (calculated at US\$0.13/aree); Payment of application fee (\$2,000) per application; Evidence / Proof of address; Registration or Incorporation documents, if applicant is a company. Applicants have the option to apply for parcels according to grid numbers and the GGMC provides the cartographic description and map for a fee.

Question: What are the requirements for application for a Mining Permit?

Answer: Applicants must have a valid PPMS. Completed Form SF Application Medium Scale; Map and cartographic description of area; Payment of a deposit equivalent to the first year's rental (calculated at USS1.00 per acre); Payment of application fee (\$2,000) per application; Evidence / Proof of address; Registration or Incorporation documents, if applicant is a company. Applicants will be required to post an environmental bond of \$100,000 and sign an Environmental Management Agreement prior to issuance of the Mining Permit.

Question: What are the procedures after a Prospecting Permit application has been filed?

Answer: A verification will be done to ascertain whether the area applied for is available to be granted. If it is, the relevant stock sheet will be updated with the applicant's information and a notice of intention to grant will be published in the Official Gazette. If no objection to the notice has been raised, the applicant will be notified to pay 'difference in rental'. A permit will be issued once payment has been made. However, if the area is not available to be granted, the applicant will be notified and advised to claim his deposit. Application fees are not refundable.

MINING OPPORTUNITIES IN GUYANA QUARTERLY MINING SUPPLEMENT

March, 2012

The Ministry of Natural Resources and the Environment was established by His Excellency President Donald Ramotar to have oversight responsibilities for forestry, mining, wildlife, environmental management, protected areas and land management. The sectors contributed significantly to the country's social and economic development in 2011 and further transformations and expansion are anticipated. At the same time they allow Guyana to fulfill its national and international environmental obligations. The Ministry which, was Officially Gazetted on December 17, 2011, has responsibilities for the following agencies:

- Guyana Geology and Mines Commission
- Guyana Forestry Commission
- · Guyana Lands and Surveys Commission
- Guyana Gold Board
- · Environmental Protection Agency
- · National Parks Commission
- · Wildlife Division

According to the Minister of Natural Resources and the Environment, Hon. Robert M. Persaud, the development of mineral resources is one of the key drivers of economic growth in Guyana. Mining has the potential to transform economies and societies, including some of the world's poorest nations, but the extent to which it will fulfil that potential is to be determined.


Minister Persaud stressed that his Ministry will examine where stakeholder's discontent and frustration most commonly arise, where improvements can occur, and what can be done to foster more responsible, sustainable mineral development, thus enabling better integration of mining wealth into the national economy. Whilst the first phase of this initiative is focusing on identifying the challenges to responsible mineral development, the second phase will summarize stakeholder's views on how to address these challenges.

He added that the vision of the Ministry is to contribute to sustainable national, social and economic growth, through creating a conducive environment for natural resource development, in all the regions of Guyana. Emphasis will be placed on equal opportunities for all miners to ensure sustainable development and management of natural resources by the public and private sectors in a transparent manner for socio-economic benefit for all of Guyana.

Exploitation of natural resources should be pursued in order to help a country meet its broader social and economic goals, not as an end in itself, the Minister stated. This is being done in the in the context of following the path of the green economy that has gained currency to a large extent because it provides a response to the multiple crises that the world has been facing in recent years—the climate, food and economic crises – with an alternative paradigm that offers the promise of growth while protecting the earth's ecosystems and, in turn, contributing to poverty alleviation.

Moreover, the Ministry is working with all stakeholders on a natural resources and environmental governance sub-programme which is focusing on strengthening national, regional and local environmental governance to address agreed environmental priorities and a resource efficiency sub-programme that is focusing on reducine the adverse environmental impacts.

Further, the Ministry of Natural Resources and the Environment is also working with several international agencies and departments to encourage greater transparency in the country's rich natural resources to mitigate some of the potential negative impacts of mining. Meanwhile, Minister Persaud stated that the government is committed to greater transparency, strengthening accountability and good governance, as well as promoting greater economic and political stability.



OVERVIEW OF THE MINING SECTOR

In 2011, 363,083 metric ounces of gold were declared which represents a 13.46 % increase over 320,000 metric ounces than what was projected for the year. Bauxite production of 1,712, 284 metric tonnes was 4.04 % above projection of 1,702,436 metric tonnes and stone production of 488,030 metric tonnes was 22.01% above projection of 400,000 metric tonnes.

Diamond production of 52,273 metric carats was 12.88% below the projection of 60,000 metric carats as miners switched to gold mining, and 354,828 tonnes of sand was produced, 40.86% below the projection of 600,000 tonnes. Loam production was 12,133 metric tonnes with a 708.87% above projection of 1,500 tonnes.

GGMC was able to record successes in its approved Work Programme for 2011, and realization of its budgeted financial projections.

- d) A co-operative society registered under the Co-operative Societies Act
- e) A public corporation, or any other corporate body established by or under any written law in force in Guyana; or
- f) Any organization established by the Government or by or under any written law in force in Guyana and authorized to carry on mining operations.
